The Economics Associate in Arts Degree for Transfer, also referred to as the Economics AA-T degree (or ADT), prepares students to transfer to CSU campuses that offer bachelor's degrees in Economics. The coursework emphasizes the practical applications of economics and knowledge in a diversity of careers and the utility of economics perspectives as a life-long learning tool for interpreting world economic events. Students will acquire a fundamental knowledge base of economics, learn basic knowledge and possess a basic understanding of areas that have an interdisciplinary association to Economics. This degree requires students complete 60 CSU transferable units, including completion of CSU GE or IGETC and 20-25 units in the major with a cumulative GPA of 2.0 or better. Title 5 requires that students earn a grade of "C" or better in all major coursework.

Note: It is strongly recommended that students meet with a Fullerton College counselor to review the AA-T requirements.
